## Minutes – PVS ExCom Meeting – March 19, 2024

MEETING ATTENDEES: ExCom held its meeting via Zoom, hosted and facilitated by Cara Jablon. SKI TRIP COMMITTEE REPORT: Ski Trip coordinator, Kathy Lake, reported that twenty rooms have been reserved for the Snowmass trip on January 8-15, 2025, with Doug Horstman as the vendor. Cara Jablon said she would like to lead the BRSC Western Carnival at Park City, February 1-8, 2025. Cara just returned from a ski trip to Park City and stayed at the Doubletree Hotel where the BRSC trip members will stay. She said it was a nice hotel but not on the mountain. The bus stop is across the street, a block away. The other option is the Yodle Hotel which is near the Canyons. She recommended the Doubletree Hotel for our group. Bob mentioned that there is a shopping center next to the hotel with lots of dining and shopping options. Kathy Lake moved to approve the BRSC Park City trip. Bob Knopes seconded the motion.
